*Limitations and Conditions Continued:*

Instructions for Continued Airworthiness (ICA), Avionics Support Group Document 21152-ICA, Rev. B, dated May 28, 2013, or later FAA accepted revision must be made available to the operator at the time of installation. This installation requires integration with a previously certified air to ground transceiver. The CTR does not interface with aircraft systems and is disabled below 10,000 ft.

Based on 14 CFR §§ 21.115 and 21.101, and the FAA policy for significant changes in FAA Order 8110.48, the certification basis for Cessna Citation 525B series aircraft is as follows:
